ORDER:

The TREI-RB vide in Notification No 02, dated 30.06.2018 had issued General Recruitment for the 1972 posts of PGT in TSWREIS/ TTWREIS/MJPTBCWREI/TMREIS/TREIS. Some candidates, while applying for the above posts online, have entered their particulars relating to disabilities to the effect that they are of the category of VH, HH and OH. In fact, they do not come under the said category.

Because of this reason some of them have been included in 1:2 and 1:1 provisional selection lists and the candidates, who should have been included in the above lists on the basis of their merit could not find place. The Board had to do a lot of work in noticing the ineligible candidates, who are included in the above lists and in replacing them with eligible candidates. To avoid such situations, in future, and for making candidates, who apply for various examinations, should be more careful and attentive, the Board had decided to take stringent action against them.

Accordingly, under sub para-4 and para-5 of the Notification 2nd read above, the TREIRB hereby debar the candidates, whose hall ticket numbers and other particulars are given below, from writing all competitive examinations, which are conducted by TREI-RB, for a period of one year from date of issue of this order.

ORDER:

Smt. Shaheen Begum (Hall ticket:514862), PGT (Urdu) has represented that she does not come under the Category of VH, HH and OH and that during the submission of her application mistakenly the said category option had been selected and she apologized for the same and requested to forgive and to remove her name from debarred list along with Hall ticket number.

After careful consideration of the request of Smt. Shaheen Begum, the TREI-RB hereby, remove the Hall ticket number and other particulars pertaining to her from the Proceedings 3rd read above. She is advised to be more careful and attentive while submitting applications to the TREI-RB in the future.
