Selection Amendment Notification

In Selection Notification dated: 28.02.2019, TREIRB has notified Hall Ticket Numbers of 283 candidates, who are provisionally selected for the posts of PGT (Telugu). Sri. G. Rajender S/o Lasmana, in his application dated:17.03.2019 has stated that his date of birth is 14.11.1982 and that he belongs to SC Community and presently serving in the Indian Army (Crops Signals) in the rank of Havildar. He has stated that he joined the said service on 23.03.2005 and that his pensionable service duration as per SPE(Specific Period of Engagement) is 15 years, which will be completing by 23.03.2020. He has further stated that he has been selected for the post of PGT (Telugu) but he can join as PGT (Telugu) only after 31.03.2020, and that he can be released at his request by Indian Army but he may be ineligible for some of emoluments if he resigns before completion of SPE i.e., 23.03.2020 and that he may suffer irreparable loss and hardship if he loses his job and therefore he has requested to consider his representation and avail himself an opportunity to join as PGT (Telugu) i.e., after 23.03.2020.

As on the date of Notification No. 2 i.e., 30.06.2018 in which General Recruitment for the posts of PGT has been issued and during the written examination i.e., in September '2018 and October' 2018, the individual was still serviceman and that he will become Ex-Serviceman only after his successful completion of service on 23.03.2020 and then only he can claim benefits as Ex-Serviceman from 24.03.2020. Therefore, the Director of Sainik Welfare Department was requested to intimate whether writing of the written examination without completing the service in Indian Army by claiming as Ex-Servicemen is in order.

The Director, Sainik Welfare in his reply dated:10.04.2019 has quoted the following explanation from Telangana State and Subordinate Service Rules regarding Ex-Servicemen:-


“The persons serving in the Armed Forces of the Union, who on retirement from Service, would come under the Category of Ex-Servicemen, may be permitted to apply for re-employment one year before the completion of the specified term of engagement and avail themselves of a concessions available to Ex-Servicemen but shall not be permitted to leave the uniform until they complete the specified term of engagement in the Armed Forces of the union.”

Sri. G. Rejender's retirement is on 23.03.2020. According to the above rule position he was eligible to apply for re-employment after 23.03.2019. But Sri. Rajender has applied for the post of PGT (Telugu) on 09.08.2018. Therefore, submission of application is not correct. He belongs to SC Category of Zone -V. But selected in Ex-Servicemen quota. He secured 83 marks and his rank is 3760. In Zone-V male SC last selected candidate secured 123.75 marks and his rank is 228. Therefore, he cannot be selected as SC candidate also.

In view of the above, the TREIRB, after careful consideration, hereby delete the Hall Ticket Number and other particulars which are indicated below, from Selection Notification dated:28.02.2019.
